PARENTAL CONCENT FOR A MINOR

Dear MYSAR Parent(s),

Mendocino Youth Search & Rescue (MYSAR) will provide your child with the opportunity to work along side and interact with the regular adult members of the Mendocino County Sheriff's Search and Rescue Unit during regular activities. In Search and Rescue, your child will be involved with numerous different tasks during searches and trainings; tasks which could include the following; hiking, ATV riding, rappelling, low angle climbing or scrambling, diving, working with K9s, horse back riding, riding in helicopters, helping with rope rescues or recoveries and various other logistical tasks. Before your child is assigned to a task, Search and Rescue will ensure they have been trained appropriately as to mitigate risks.

Although every attempt will be made to minimize it, your child will have exposure to critical incidents involving lost persons, injured or possibly deceased persons. It is not very common, but exposure to these incidences does occur and can be disturbing to some. It is our intent that the exposure to theses incidences be as limited as possible, but they can and will occur at a moments notice.

Throughout the year there are regular training sessions in such diverse subjects as tracking, map and compass, rappelling, swift water rescue, first aid & CPR and related fields. Apart from attending the meetings and training sessions, all members will be called upon to participate in searches. Searches are often done in rugged terrain at all hours of the day and night, and in all types of weather. Searching is physically and physiologically demanding and one must be in shape to effectively participate. Search and Rescue leadership will do everything possible to assure your child's safety during searches and trainings. We will further attempt whenever possible to limit their exposure to critical incidents.

It is the intent of this letter to notify you as the legal guardian, that you may prohibit your child from participating in All or Any specific Search and Rescue Activities.

Please initial all activities that you approve your child to participate in after they have had an appropriate amount of training.

Whether in meetings, trainings or on missions, members should refrain from behavior that is inconsistent with the Mendocino County Sheriff's Search and Rescue Standards of Behavior, especially while in the public eye. Participation should be focused and not distracting to others. Attitude must remain positive, no matter what the task or the enjoyment level. Voicing dissatisfaction or providing feedback should be done professionally and should follow the chain of command. Gossip or complaining will not be tolerated.
60E'qo o ko gpw	MYSAR Members must honor commitments to others. As a team, Search and Rescue members depend on each other to complete their assignments. Whether to the public, an affiliated agency or Search and Rescue Leadership, members must honor their commitments.
50Grades	MYSAR Members must maintain a "C" average or above in their school grades and attendance. MYSAR members are responsible for providing evidence of his or her grades in the form of a report card or transcript to Search and Rescue leadership on an annual basis in order to remain in good standing.
